#### **B:** Conditions of Entry

#### 1. Introduction

- 1.1 These Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between the Conditions of Entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. # 2. Event Entry

- 2.1 By submitting an entry to the Event, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.

The Organiser has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

## 9. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Nestlé Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Event, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Event or violation of the Terms and Conditions.
